Thursday, April 12, 2018.

Met at thirteen minutes past eleven o'clock A.M. (Mr. Boncore in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Christos Dalmanieras then led the Chair (Mr. Boncore), members, guests and staff in the recitation of the pledge of allegiance to the flag.

*Distinguished Guests.*

There being no objection, the Chair (Mr. Boncore) handed the gavel to Mr. Pacheco for the purpose of an introduction. Mr. Pacheco then introduced, in the rear of the Chamber, the Middleborough High School Football Team. The team was recognized for winning the Division 6 State Championship defeating Littleton High School 43-20. The Senate applauded their accomplishments, they were presented with Senate Resolutions and they withdrew from the Chamber. They were accompanied by Head Coach Patrick Kingman and Assistant Coaches: Albert Keich, Steve Fernandez, Greg O'Sullivan, Mike Grandfield, Mark Lemon and Sam Botelho.

PAPERS FROM THE HOUSE

*Engrossed Bill.*

An engrossed Bill amending the charter of the town of Chelmsford (see House, No. 4243) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and signed by the Acting President (Mr. Boncore) and laid before the Governor for his approbation.

The House financing improvements to municipal roads and bridges (House, No. 4367),— came from the House with the endorsement that the House had NON-concurred in the Senate amendment (striking out all after the enacting clause and inserting in place thereof the text contained in Senate, No. 2409), and had asked for a committee of conference on the disagreeing votes of the two branches; and that Representative Straus of Mattapoisett, Kulik of Worthington and Muradian of Grafton have been appointed the committee on the part of the House.

Municipal roads and bridges.

**On motion of Mr. Tarr the Senate insisted on its amendment and concurred in the appointment of a committee of conference; and Senators Boncore, Keenan and Tran were appointed on the part of the Senate.**

**The bill was returned to the House endorsed accordingly.**
